2. Partnership content

2.1. Please describe briefly the Partnership activities undertaken and the results achieved so far:

Within the project there have been carried out three partner meetings so far:

- 1. in Miskolc (11. 14. October 2012)
- 2. in Třebíč (17. 20. January 2013)
- 3. in Angermünde (5. 8. June 2013)

The main purpose of the meetings was:

1. Miskolc (Hungary):

Presentation of project content, schedule of meetings, setting objectives and targets for individual mobility and the individual participating institutions, the preliminary program of meetings, economic issues, the question of evaluation, dissemination, global tasks for each partner.

Program of the project had to be modified due to the fact that for partners from Latvia the project was not approved. It was agreed that its partner tasks will be taken over by Hungary.

Each partner also introduced innovations in their organizations, particularly focused on informal education and evaluation.

All partners attended the event to celebrate "100 years of Andrassy school"

Participation of our school: JUDr. Josef Dvořák, Ing. Tomáš Holomek Confirmation of mobility – see Annex 1.

2. <u>Třebíč (Czech Republic)</u>

The meeting took place in our school. We invited our social partners to participate at the meeting with brief presentations focused on the project activities – informal education. The invitation was accepted by representatives of institutions: Chamber of commerce in Trebic – Ms. Neumann (presentation about ESF – funded project focused on informal training – "Break The Wall"), the National Institute of Education – Mr. Nemjová (UNIV project presentation), Vysočina Education – Mgr. Roman Křivánek (support for teacher training), Technical High School Jihlava – Ing. Miroslav Vítů, headmaster (Lifelong Learning Center).

Partners vividly discussed the experience with the use of informal learning in everyday professional /scientific practice.

Working in the framework of the project on the topic: the drafting of informal learning indicators (what are the demands of the economy?) The effectiveness and usefulness of their use. Questionnaires used in Sweden – discussion whether something similar would be accepted by companies or unemployed people, people without education, or students.

Another point of the visit was the presentation of new educational courses and related technical equipment of our school. Mr. Bobek (teacher of maths and chemistry) presented his experience from the placement in Nuclear Power Plant. The participants were really interested about it.

Finally the German partners introduced the possibility to participate in another project, which is linked with the current project – "a practical guide" as a tool of good practice, the development of measuring the effectiveness of training, Senior Academy, through the use of existing knowledge).

Task for the next meeting:

Prepare information about informal learning – experience, possibilities to certificate informal learning.

Term of the meeting in Angermünde was agreed.

Participation of our school: Ing. Tomáš Holomek Confirmation of mobility – see Annex 2.

3. Angermünde (Germany)

Partners discussed "methods of recording" of informal learning. Except the regular participants, the representative of Chmber of Commerce was present. His report was aimed at informal learning and the role in economy. There were discussions about National System of Education, examples of recording the informal learning.

Partner from Teplice (Czech Republic) introduced electronic system for collecting of data relative to the periodic training and testing blue collars within their profession in AGC Flat Glass Czech a.s. company.

Finally we established new rules in multimedia competition for our students within INCO–NET partnership.

There was also cultural programme involved – concert (part of musical festival in Angermünde).

Tasks for the following meeting:

The creation of a questionnaire to assess informal learning. Development and binding design and implementation of coordinated questionnaire to assess informal learning. Common questionare focused on general knowledge/competences – knowledge gained during free time activities, knowledge gained during working process (e.g. summer job).

Term of the meeting in Teplice was agreed.

Participation of our school: Ing. Jaroslav Myslivec, Ing. Tomáš Holomek, Mgr. Eva Morávková, Sandra Mazzolini Confirmation of mobility – see Annex 3.

2.2. What problems/obstacles, have you met in the implementation of the Partnership, if any? How have these problems been solved?

- 1. There is a problem due to non–approval of the Latvian partner project. Question has been raised whether the planned mobility activities can be taken by one of the partners or whether to repeal them. With the support of NA in Hungary, the issue was clarified. The tasks of the Latvian partner took over the Hungarian institution.
- 2. Next problem is joined with our school. After a long and serious illness has died headmaster JUDr. Josef Dvořák, who was also responsible for school involvement in the project. As a new director was appointed Ing. Jaroslav Myslivec. Authorization for the project by the legal representative is attached in the Annex 4.
